

16. Secretary & Treasurer :

The Secretary & Treasurer shall manage the day to day affairs of the society and meet the expenses in connection there with subject to superintendance, guidance and control of the Executive Committee. He shall also convene meeting of Executive Committee and also of the General Body and keep the minutes there of.

17. Executive Committee Meeting :

1. A meeting of the Executive Committee members will be convened once in three months at a specified place and date after with prior notice of 10 days. The quorum of meeting shall be, 1/3 of the total membership of 4 executive whatever is less. All resolutions of the executive committee shall be carried out by a majority of votes. II. Executive Committee :

- b. The Executive Committee shall consist of one President, One Vice President, One Secretary, One Treasurer and 3 Executive members.
- c. The term of office of the President, Secretary, Treasurer and members of the Executive Committee shall be three years.
- d. The members to the Executive Committee shall be elected by the General Body, and the office Bearers shall be elected by the members of the Executive Committee.

18. Power of Executive Committee :



EXTRACT OF THE SPECIAL RESOLUTION PASSED IN THE EXTRA-ORDINARY GENERAL BODY MEETING OF THE SOCIETY HELD ON 17TH MARCH 2016, AT SOCIETY FOR EDUCATION FOR LIFE, ST. JOSEPH'S HOUSE, 2 / 17 - X, RUDRA ROAD, ST. THOMAS MOUNT, CHENNAI - 600 016.

The President brought to the notice of the members that there is a requirement from the bankers for the purpose of obtaining loan for our educational institutions. The appropriate authorities have advised us to amend the following clause contained in the Memorandum of Association of Our Society to create a charge on the immovable properties belonging to the Society by mortgaging them in favour of third parties, more particularly, Societies or Trusts coming under the SEL group to enable them to raise credit facilities. There are opinions from different advocates that there is no bar on Societies for mortgaging or giving guarantees in favour of third parties.

As the existing bye laws of Society for Education for Life do not specifically provide for such provision of creating mortgage of immovable properties and / or extending its guarantee in favour of third parties, it is deemed essential to make an amendment to the existing bye laws. However, such creation of mortgage and / or extension of guarantee shall be restricted to within the entities only.

The President also informed members that Income Tax Department, Government of India, has given their approval to this amendment.

The following resolution is there being moved for approval of the members of the **Society for Education for Life** for amending the Bye Laws.

After deliberations, the resolution was approved unanimously.

RESOLVED TO amend the bye laws of the **Society for Education for Life** as given below:

EXISTING CLAUSE	AMENDED CLAUSE
The present bye laws have no express provision for providing the immovable properties as security by way of mortgage and / or extend guarantee to secure the credit facilities availed by third parties..	A New clause 18(a) is to be added. The Executive Committee is authorized to decide to provide the immovable properties as security by way of mortgage and / or extend guarantee of the Society to secure the credit facilities availed by third parties. Third parties will mean the Societies or Trusts that are part of the DMI group only.

The Secretary is authorized to take required steps to obtain the approval of the amendment made to the bye laws from the Registrar of Societies.
